First Baptist Church, Clinton has a rich history doing ministry and supporting missions and missionaries around the world. Since 1881 we've


- Planted Calvary Baptist Church over 100 years ago.

## The First Baptist Church Endowment Fund

is established to provide members and friends the opportunity to make charitable gifts to First Baptist Church, Clinton, SC that will become a permanent endowment of financial support and a living memorial. The Fund is not intended to supplant the annual operating budget but to be a supplement to support mission activities and the preservation of our church's campus.

Gifts may be designated for the following purposes through the corresponding sub-funds of the Permanent Endowment Fund:

### **Undesignated:**

#### **General Endowment Fund**

(used for support for FBCC ministries, needs, or facilities)

## **Designated:**

Missions Endowment Fund (mission activities, trips, special projects)

Capital Improvement Fund (structures, preservation or upkeep)

#### **Unrestricted:**

(functions like a cash account—to hold earnings but also any unrestricted gifts given)

# **Sowing Seeds Today**

Contributions, large or small, may be made to the First Baptist Church Endowment Fund at any time. There are a number of ways you might consider contributing:

- Through an outright gift of cash, check or E-giving
  - gifts can be made in honor or memory of a loved one
  - honorariums and memorials will be acknowledged as requested by the donor.
  - gifts are tax deductible and receipts
    will be provided.
- Through a gift of stocks, bonds, or real property
- ◆ Through a bequest in a Will naming The Endowment Fund as a beneficiary
- ◆ Through a Charitable Remainder Trust or Charitable Gift Annuity, which allows a donor to ultimately give to the Fund while receiving income during his or her lifetime.
